Altogether, some 100 000 copies were sold. The research was commissioned by research foundations, professional societies, Dutch government departments, the Phare Programme of the European Union or it was carried out as academic research.

- Towards the Third Generation University Navigating the university in transition, published by Edward Elgar Publishers in January 2009; published in Macedonian in 2008 and in Polish and Turkish in 2009 and as an early version in Polish and Bulgarian in 2006.
- The art of strategic entrepreneurship 16 (revised) reprints since 1986 in Dutch, translated into Russian; completely revised edition, 2001, reprinted in 2002.
- Unit Management: entrepreneurship and co-operation in the decentralised firm, 8 (revised) reprints in Dutch since 1988, awarded by the Dutch Association of Management Consultants, also published in English (with an American version), Spanish, Italian, Russian, Turkish and Bulgarian;
- Fear of change? A myth!, 8 reprints in Dutch since 1986;
- Are managers driving through the red light?, in Dutch (1997), on missing or neglecting warning signals and irrational management behaviour in decision making.
